The average adjustment rule will apply (rule 319e)

It is each bowler's responsibility to verify the accuracy of their own average,
whether originally submitted by the bowler, the team captain or others.

Failure to use the correct average may disqualify the score, if submitted
average is lower than the correct average, thereby resulting in more
handicap. Prize winnings will be based on the submitted average, if it is
